# GOLF CART RULES

## GUESTS

*The sponsoring member shall be responsible for the conduct of his or her guests which includes obeying all rules pertaining to road cart rental, safety and operation as detailed below.*

## OBEDY

All traffic signs and rules of the road.  
*No road carts are allowed on golf courses.*

## DRIVER RESPONSIBILITIES

VALID STATE DRIVER'S LICENSE REQUIRED TO OPERATE THIS CART.

## AVOID

Quick sharp turns, quick sudden starts and stops, overloading passenger carts. Passengers do fall out.

## USE SEAT BELTS

Passengers must be seated with children seat belted. Children are not permitted in laps nor "steering" the cart.

## CAPACITY

The number of passengers may not exceed the number of seats designated.

## NO TEXTING

Texting is prohibited while operating the cart.

## DAMAGE

Lessee is responsible for any and all damage, regardless of how or by whom damage resulted.

## LOUD MUSIC

Music should not be audible by anyone except your passengers.

## AGE REQUIREMENT

Persons under the age of 16 must be licensed by ORCA and wear ORCA issued lanyard while driving and may not drive after dusk. See Permits & Licenses at right.

## PERMITS & LICENSES

A family member of Club Members who is at least ten may take the written and driving test to earn a learners permit. Permitted drivers must be accompanied by someone 18 years or older and wear the lanyard provided by Ocean Reef Public Safety when driving a cart. A family member at least 12 who has possessed an ORCA learners permit for at least a year may apply for an Ocean Reef Golf Cart License.

## PLEASE CART SAFELY

Failure to follow these rules will be considered a violation of the cart rental agreement and could result in disciplinary action.



# RULES AT A GLANCE

## IMPROPER CONDUCT

Any member whose conduct shall be deemed by the Board to be improper or likely to endanger the welfare, safety, harmony or good reputation of the Club or its members, may be reprimanded, fined, suspended or expelled from the Club. The Board shall be the sole judge of what constitutes improper conduct or conduct likely to endanger the welfare, safety, harmony or good reputation of the Club or its members.

## GENERAL RULES

Alcoholic beverages shall not be served or sold, nor permitted to be consumed, on the premises during hours prohibited by law. Alcoholic beverages shall not be sold or served for off-premises consumption to any person not permitted to purchase the same under the laws of the State of Florida.

Members and their guests may not abuse any of the employees, verbally or otherwise. All service employees are under the supervision of the President and no member or guest should reprimand or discipline any employee or send any employee off the Club's facilities for any reason.



Any employee not rendering courteous and prompt service should be reported to the President immediately.

Cellular telephones shall not be used for voice calls or facetime audio or video calls in any of the Club's enclosed facilities. Cellular telephones may be used for voice calls or facetime audio or video calls at the Club's outdoor facilities provided that such calls are conducted quietly and courteously so as to avoid disturbing others.

## BUCCANEER ISLAND

When enjoying the recreational areas of Buccaneer Island, please note that coolers are not permitted, nor are radios. Smoking is also prohibited on Buccaneer Island. As a courtesy to fellow members, lounge chairs may not be reserved and should a chair be unoccupied for more than thirty minutes, belongings will be collected and the chair will be available to others.

## CHILDREN

Children under 12 years of age are permitted to use the Club's facilities only if accompanied or supervised by an adult, subject to additional limitations set forth in other provisions of these Rules and Regulations. Children under the lawful drinking age are not permitted in any lounge unless accompanied by an adult. Members are responsible for their children when on the Club's facilities.

## PETS

Dogs and other pets, with exceptions for service animals as required by law, are not permitted on the Club's facilities without the approval of the Club. Boat owners are permitted to have pets provided they are kept on the vessel or on a leash in specially designated areas. Members are responsible for any damage caused by a pet owned by the member or under the member's control, and also for cleaning up pet droppings.

## GUESTS

A sponsoring member shall be responsible for the conduct of his or her guests. If the manner, deportment or appearance of any guests is deemed to be unsatisfactory, the sponsoring member shall, at the request of the Club cause such guests to leave the Club. Guests may not use Member cards. All guests of Social or Legacy members must be

accompanied by the sponsoring member. This applies to both day guests or those guests enjoying overnight accommodations.

Social and Legacy members may have a maximum of six accompanied guests, including lineal family, for the day. For guests staying overnight, sponsoring Social and Legacy members must be staying overnight for the same time period.

## TWO-VISIT RULE

No person, other than a house guest, or child of a Club member, as set forth herein in the sections entitled "Guests" and "Children," shall be permitted to visit the Club more than two times in any five year period, with each visit to be limited to a maximum of 14 days, without becoming a member of the Club. This shall be known as the "two visit rule."

## MEMBERSHIP CARDS

A membership card reflecting an account number and the category of membership shall be issued to the member as well as to his or her immediate family upon payment by the member of the required membership contribution, Capital Contribution (if applicable), and all dues. Membership cards must be presented upon request when signing in for use of the Club's facilities. Membership cards are not transferable.

## SOCIAL MEDIA POLICY

Posting of information relating to the Club on social media sites is permissible so long as nothing is posted which is detrimental to or which would harm the reputation or good will of the Club.

## PRIVACY POLICY

Privacy at the Club includes proper deportment at all times by all members and their guests so as to avoid causing any undue notoriety for the Club, and having a continuous mutual respect for the absolute privacy of the Club's members.

## NUISANCE POLICY

In an effort to maintain the peace and quiet enjoyment of the Club and its facilities and in recognition of the expectation of reasonable privacy of members and guests of the Club, no individual shall be permitted to commit any nuisance within the Club.

# DRESS POLICY

The Dress Code has been a long standing and cherished tradition of Ocean Reef Club. The standards of dress are by direction of the House & Grounds Committee and in the rules as designated by the Board of Directors.

## DINING ATTIRE

The required attire for gentlemen in all restaurants is best described as Club Casual – collared shirts and dress trousers and equally appropriate attire for ladies. Frayed or torn clothing is not permitted. Midriffs must be covered. Shorts, if worn, must be of walking length. Smart long denim jeans are allowed in all of our outlets, with the exception of CH Prime and CH Lounge. Jackets are required in the Members-only CH Prime and CH Lounge.

## HEADWEAR

Gentlemen are expected to remove their hats whenever entering a Club facility, excluding the Raw Bar, Burgee Bar, Grill Room for lunch and Fitness Centers, where headwear is acceptable. Wearing baseball-style caps backwards is not acceptable in any Club area.

## RECREATION ATTIRE

Cut-off, unhemmed shorts as well as frayed or torn clothing/denim are not allowed. Each recreational area also has dress requirements, as follows:

## GOLF

Golf courses and Driving Range require collared shirts with sleeves (no mock turtle necks) and appropriate golfing shorts or slacks (no cargo or athletic shorts) for men. For both ladies and men, t-shirts are not permitted, garments must be conservative in nature and may not have large lettering or graphics. Sleeveless golf blouses with

collars are permissible for ladies, as is other appropriate golfing attire. Golf shoes must have non-metal spikes and fully cover the heel and/or toes. Shirt tails must be tucked in at all times.

## TENNIS, PICKLEBALL & CROQUET

Tennis requires appropriate tennis clothing and footwear. Short and long tights must be covered. Pickleball permits fitness attire and footwear. Midriffs must be covered, gentlemen's shirts must have sleeves. All-white attire must be worn on the Croquet Courts. Swim trunks and non-athletic graphic t-shirts are not permitted at the Tennis & Games Center.

## BATHING ATTIRE

One- or two-piece bathing suits that provide full coverage are acceptable. Bathing cover-ups, as well as footwear, must be worn in all areas away from the beach and pools on Buccaneer Island. Athletic-style tank tops are permitted for men on Buccaneer Island.

## FITNESS CENTER & OUTDOOR EXERCISE





Shirts must be worn for jogging, walking and other forms of exercise within the community. All shirts worn by gentlemen must be hemmed, and, if sleeveless, reach shoulder length. Ladies' shirts must have full coverage. Proper athletic footwear is required in the Fitness Centers.

Shirts with sleeves, shorts of walking length & jeans permitted.


**Fitness Café**  
Shirts with sleeves for men and full coverage shirts for ladies.

**Toski's**  
Must meet the standard of dress as detailed in the Dress Policy.


## LUNCH

**Palm Court**   
Shirts with sleeves, shorts of walking length & jeans permitted.

**Raw Bar**   
Shirts with sleeves, shorts of walking length & jeans permitted.


**Grill Room**   
*Members Only*  
Collared shirt, shorts of walking length & jeans permitted.


**Toski's**  
Must meet the standard of dress as detailed in the Dress Policy.


**Reef Hut**   
Shirts with sleeves, shorts of walking length & jeans permitted.


**Beach Bar & Beach Grill**   
Bathing suit coverups and athletic-style tank tops are permitted. Footwear is required.

*Members Only*  
*Reservations required*  
Collared shirt, trousers and jackets are required.


**Gianni Ristorante**   
*Reservations required*  
Collared shirt, shorts of walking length & jeans permitted.

**Ocean Room**   
*Reservations required*  
Collared shirt, shorts of walking length & jeans permitted.


**Islander & Sushi Bar**   
*Reservations required*  
Collared shirt, shorts of walking length & jeans permitted.


**Reef Lounge**   
Collared shirt, shorts of walking length & jeans permitted.

**Burgee Bar**   
Shirts with sleeves, shorts of walking length & jeans permitted.

**Raw Bar**   
Shirts with sleeves, shorts of walking length & jeans permitted.

## COCKTAILS/SWEETS


**CH Lounge**   
*Members Only*  
Collared shirt, trousers and jackets are required.


**Reef Lounge**   
Collared shirt, shorts of walking length & jeans permitted.

**Burgee Bar**   
Shirts with sleeves, shorts of walking length & jeans permitted.

**Beach Bar & Beach Grill**   
Bathing suit coverups and athletic-style tank tops are permitted. Footwear is required.

**The Point**  
*Members Only*  
Shirts with sleeves, shorts of walking length & jeans permitted.

**Port O' Call Wine & Spirits**   
Shirts with sleeves, shorts of walking length & jeans permitted.

**Reef Treats**   
Shirts with sleeves, shorts of walking length & jeans permitted.

## ADDITIONAL REQUIREMENTS:

Equivalent attire for ladies. Cut-off, unhemmed or tattered jeans or shorts are not allowed anywhere on property. Midriffs must be covered when inside any Club facility.

Use of cell phones in any of the Club's restaurants and Fitness Centers is not permitted.

Hats should be removed whenever entering a Club restaurant, excluding Raw Bar, Burgee Bar, Grill Room, Reef Hut, Reef Treats and Fitness Centers. Hats may not be worn backwards.

## BUCCANEER ISLAND DRESS CODE:

Bathing suits that provide full coverage are required. Athletic-style tank tops permitted for men. Cut-off, unhemmed shorts as well as frayed or torn clothing/denim are not allowed.

Bathing cover-ups, as well as footwear, must be worn in all areas away from the beach and pools on Buccaneer Island.
