The Medical Center has received confirmation that a pending lab result has been confirmed POSITIVE. The Medical Center has provided the member with quarantine protocols. In addition, the member has been instructed to contact those individuals who they may have been in contact with. The Department of Health, Monroe County will be overseeing contact tracing.
