## STARTING TIMES

Members may book tee times by downloading the Ocean Reef App:

- Log in with your member login and password; choose Golf icon.
- Click on “tee times” at the bottom of the page.
- Press Menu in upper left for drop-down choices.

OR by calling the Golf Shop at 305-367-5912 or through the Club’s website: [www.oceanreef.com](http://www.oceanreef.com) and following the prompts for golf as detailed here:

- Login with username and password
- Scroll to bottom of welcome page, click on “request a reservation”
- Choose “golf”
- You will be directed to the homepage of ForeTees.
- From the tabs at the top of the page, choose “tee times”

A drop down menu with choices will appear and you can book your tee time.

You will also be able to view and sign up for events, lessons, enter a score and search your past history in ForeTees. There is a Help button which will answer the most frequently asked questions as well as videos that will walk you through the process.

Of course, if you need any additional help, have any questions or would like us to help you, we are available in the Golf Shop during our business hours. If you are still having trouble with ForeTees, please feel free to bring your laptop or iPads into the Golf Shop and Sam Kirkland will show you step by step.

## TEE TIME BOOKING RESTRICTIONS

During the season, November through May, the following restrictions are in place for the Dolphin and Hammock Courses:

### TEE TIMES BEFORE 12PM

Patron	Up to 14 days in advance
Charter with Golf Membership	Up to 7 days in advance
Charter	Up to 3 days in advance
Legacy	Up to 3 days in advance
Social	Up to 3 days in advance

### TEE TIMES AFTER 12PM

All Members	Up to 30 days in advance
Guests	Up to 2 days in advance

## REGISTRATION

All Members without Golf Memberships and all guests of members of the Club must register in the Golf Shop by presenting their Club card before beginning play.

Failure to check in and register at least 15 minutes prior to scheduled starting time may cause cancellation or setback.

Players late for their starting time may lose their right to the starting time and shall play only at the discretion of the starter/coordinator.

Members are reminded that their guests may pay for their golf privileges with either a guest card issued in their name through the Inn or with their personal credit card; we do not accept cash. Guests may also use their credit card to make retail purchases in the golf shop but food and beverage purchases must be made with a guest card. For more information regarding guest cards please contact the Club's Reservations Department at 305-367-5000 or Concierge at 305-367-2611 ext. 7385.

## TEE TIME CANCELLATION POLICY

A fee will be charged to Members and guests that do not call the Pro Shop within 24 hours prior to their scheduled tee time to cancel the tee time. There will be a one-time courtesy waiver provided. Upon the second violation, the Member or guest will be charged 25% of the greens fees due. Non-revenue Member rounds will incur a \$25 cancellation fee per person in the tee time.

## PRACTICE RANGE & SHORT GAME AREA

The practice range and short game area are open from 7 a.m. to approximately 30 minutes before dark each day. Proper golf attire is required for adults and children. The range will be closed for maintenance every Monday from 12 to 4 p.m. The short game area will be closed for maintenance every Monday from 12 to 2 p.m.

## PACE OF PLAY

Playing golf at a reasonable pace is consistent with the etiquette of the game, the traditions of the Club, and demonstrates the proper respect for others on the course.

All groups playing are expected to meet our Pace of Play standard of:

- 4 hours or less for a foursome / 2 hours per nine holes
- 3 hours or less for a twosome / 1.5 hours per nine holes

Ocean Reef Professional Staff will ranger both courses. They are out to monitor the pace of play and to make everyone has the most enjoyable golf experience possible.

The following Pace of Play Recommendations are provided to help everyone meet this standard:

Be aware of where you are at all times relative to the group in front of you and the clock. In a four hour round you should achieve the following checkpoints:

- Reach the 5th tee in one hour
- Reach the 11th tee in two hours and 15 minutes
- Reach the 14th tee in two hours and 45 minutes
- Be prepared to play at all times
- Be prepared to tee off and play ready golf
- Always carry an extra ball
- Repair ball marks and prepare to putt while others are playing their ball
- Do not linger on the green – mark your scorecard on the next tee
- Play smart golf and be prepared to play when it's your turn
- Invite faster groups to play through at all times
- Move directly to your ball – avoid traveling in a group
- Watch other player's shots in order to minimize the need to search for lost balls
- Anticipate your shot by carrying several clubs with you
- Always rake bunkers and repair divots
- Play from the appropriate tees for your handicap
- Help others maintain a proper pace with suggestions
- Use the time spent moving to your ball to think about your next shot
- If you have reached your maximum allowable score, pick up
- Avoid entering property belonging to fellow Members



## TIPPING POLICY

Ocean Reef Club strives to provide its Members and guests with first class service at all times. To ensure we achieve this level of professionalism, we have motivated, enthusiastic employees in every area of Golf Operations, not just those in public contact positions.

To best provide this service-orientated environment, a service charge will be added to each guest green fee to cover gratuities for the entire golf staff. Consequently, additional tipping with cash is not expected by staff members, nor should cash tips be offered to them.

## DRESS CODE

For gentlemen, shorts and long pants that are specifically designed for golf are permitted. Approved styles of shorts can be found in the Golf Shop. Shorts should be of Bermuda length and end just above the kneecap.

Non-Permitted styles are as follows:

- Athletic Shorts/Pants
- Cargo style shorts or pants with baggy side pockets
- Denim of any kind
- Swim trunks
- Hoodies
- Golf sandals
- ALL GOLFERS are required to wear closed-toe golf shoes or tennis shoes

Acceptable attire for golf course and practice facilities

### **MEN'S ATTIRE:**

- A collared shirt that is tucked in is required
- Golf shorts or pants are permitted
- Golf shoes (with or without soft spikes) are acceptable

### **WOMEN'S ATTIRE:**

- Sleeveless shirts are acceptable with a collar, but do not need to be tucked in
- Skirts, shorts or dresses must be fingertip length or longer, shoe requirements are the same as for men
- Ladies' shirts with sleeves do not need to have a collar, but need to be conservative in nature
  - Shirts with sleeves need to be solid or can have a light stripe
  - No additional lettering or graphics are permitted

### **CHILDREN'S ATTIRE:**

- Attire for boys and girls are the same as for women and men as noted above



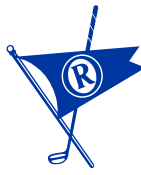
## PLAY POLICIES

1. 'Cutting-in' is not permitted at any time. All players must register with the Starter. Under no circumstances are players permitted to start play from residences.
2. All players who stop play after nine holes for any reason must occupy the next tee before the following group arrives at the tee or they will lose their position on the golf course. Should this occur, the first group must have permission from the Starter to resume play.
3. The Director of Agronomy may close the courses for adverse weather conditions, for maintenance purposes or when the course could be damaged by play.
4. For the safety of all non-golfing activities, such as jogging, bicycling, roller-blading, walking or recreation of any kind is not permitted on the courses or cart paths. The courses are closed to all after dark. Respect golfers, golf course is for golf only – not cutting through i.e. #5 Dolphin.
5. Discontinued Play Policy: Less than four holes played: full 18-hole credit. Less than 14 holes played: 9-hole credit.
6. Groups of five or more players are not permitted.
7. Ocean Reef Club allows only non-metal spikes and soft soled shoes to be worn on the courses.
8. All tournament play must be approved in advance by the Director of Golf.
9. Ball hawking and practicing are not allowed on the courses at any time.
10. Each player must have a set of clubs and a golf bag.
11. Dogs are not permitted on golf course property, leashed or loose, at any time.
12. If there are two singles in a group, they must ride in one golf cart. There is a maximum of two carts for any group over 2 players.

## INCLEMENT WEATHER

The Director of Agronomy is authorized to determine when the golf courses are fit for play and such decision shall be final. In their absence, the Director of Golf shall make this decision.

Lightning: The golf courses are not equipped with a lightning warning system or sheltered protection areas. Please leave the course immediately when lightning is present.



## GUEST PRIVILEGES

Guest privileges may be extended or limited under the rules established by the Club. The Club reserves the right to limit the number of guests that accompany a member on any given day or over the course of a membership year. Golf Members may sponsor unaccompanied guests during the year at the discretion of the Director of Golf. These requests may be limited to non-peak times. A member may have up to seven guests with him/her at a time. Daily Guests are limited to play at Ocean Reef Club six times per year, excluding Club events.

Individuals using Club facilities as guests must be registered by the sponsoring member with the Club. Guests are entitled to use club facilities only in accordance with the privileges of the membership of the sponsoring member, and upon payment of applicable fees.

## GOLF COURSE ETIQUETTE

### CELLULAR PHONES

Members and guests are not permitted to use cellular telephones on the course, in the Golf Clubhouse, or in any of the Club's restaurants. They may be used in the Golf Shop and the locker rooms.

Though these convenient means of communication have become part of our daily routine, their use results in disruption of persons nearby. Please refrain from making or receiving calls in the locations mentioned above.

### CARE OF THE COURSE

1. Please enter and leave bunkers at the NEAREST LEVEL POINT to the ball. Please smooth over with a rake upon leaving. LEAVE RAKES IN BUNKERS WITH THE HANDLE JUST OUTSIDE.
2. Please repair your ball mark on the green and at least one other.
3. Fill all divots with sand and tamp down. The par three tees will be maintained by the Golf Course Maintenance Staff.
4. Keep all four wheels on the cart path to prevent unnecessary wear.



## GOLF CART RULES & REQUIREMENTS

1. The option to walk will be available year round on the Dolphin course and pull carts are available by reservation.
2. Each operator of a golf cart on the golf courses must have a valid state issued driver's license.
3. Only two persons and two sets of golf clubs are permitted per golf cart. Four-seater golf carts are available from the Golf Shop to assist with junior play.
4. Please obey all golf cart traffic signs.
5. Please do not drive a golf cart within 30-feet of a green, tee or bunker, except on golf cart paths. Carts must stay on paths on all Par 3's and all tees. Golf carts should stay away from the edges of all bunkers to prevent damage.
6. Never drive a golf cart through a penalty area, into roped areas or within white-lined areas around the greens. Persons with handicap flag privileges will use disability flag program protocol.
7. Please be careful to avoid soft areas on fairways, especially after rain. Use cart paths or the rough wherever possible.
8. Operation of a golf cart is at the risk of the operator. Cost of repair to a damaged golf cart shall be charged to the person responsible for such damage. Persons using a golf cart shall be held fully responsible for ALL damages caused by misuse of the golf cart. The person or their guests shall reimburse the Club for all damages the Club may sustain by reason of misuse.
9. Each person using a golf cart (including the member on behalf of his or her minor children or minor guests, if they are operating the golf cart) accepts and assumes all responsibility for liability connected with operation of the golf cart. Such person also agrees to indemnify and hold harmless the Club from damages, whether direct or consequential, arising from or related to the person's use and operation of the golf cart.
10. When "cart on path only" signs are posted, they must be strictly followed. At all other times, carts should be driven according to the 90° rule: drive at a 90° angle to your ball position from the cart path. As a reminder, players should keep all four wheels on the path to minimize wear of the surrounding areas.
11. In some instances of bad weather and/or course damage or repair, it is necessary to restrict all traffic from riding on the fairways. No golf carts, including those of handicap players, will be allowed on the course under these conditions.
12. Violations of the golf cart rules may result in loss of golf cart privileges and/or playing privileges.
13. In the Gross Club Championships (if paired in twosomes) and the Keys Cup and Chairman's Cup final matches, the players can ride in separate golf carts.



## PRIVATE GOLF CART GUIDELINES

The Club will allow private golf carts on the courses provided they are registered in the Ocean Reef Club Golf Membership. This is available to Patron Members and Charter Members who have purchased the Annual Golf Membership. Ocean Reef Club has a fleet of brand new Club Car golf carts that are equipped with GPS for both the Hammock and Dolphin Courses. These carts are available to all other Members and their guests.

Signified by a Golf Membership sticker obtainable in the Golf Shop, the private carts in the Golf Membership Program must also conform to the following regulations:

- May weigh no more than 1,200 lbs.
- May be no wider than 48 inches
- Floor height may be no greater than 12 inches
- Tires may be no narrower than 8 ½ inches in width and should be of normal turf tread
- Wheel base not to exceed 70 inches
- Must be equipped with standard golf course features including golf bag attachments, sand bottles, etc.
- Custom cart designs not presently included in the annual Trail Pass Program require Golf Committee approval
- Only properly-decaled carts conforming to cart regulations are allowed on the courses, monitored by Course Rangers and Starters
- Club golf carts are always available for Member and guest usage

## WORLD HANDICAP SYSTEM

1. Handicaps are computed under the supervision of the Director of Golf in accordance with the World Handicap System.
2. To establish a handicap, Members should register with the Golf Shop. A minimum of three 18-hole rounds is required to establish a handicap.
3. All Members and their guests with a World Handicap Index may participate in Club tournaments and the weekly events. All handicaps submitted may be revised by the handicap committee. Maximum course handicap for all events is 36.
4. If a player does not have an established handicap, they cannot compete.
5. All scores must be posted in the handicap system in a timely manner using the WHS system. The maximum postable score on a hole is NET Double Bogey.
6. Scores from all major Club events and those reflected from the LGA and MGA tournament schedule will be recorded as competition scores. These scores will be identified in the handicap computer with a 'C'.
7. Players are reminded that holes that are unfinished or that have a stroke conceded should not prevent them from posting a score for the hole. Rule 3.3 in the USGA Rules of Handicapping states the procedure: If a player starts but does not complete a hole or is conceded a stroke, they shall record for handicap purposes the score they most likely would have made. The most likely score consists of the number of strokes already taken, plus, in their best judgment, the number of strokes that the player would need to complete the hole from that position. This number may not exceed the net double bogey max.
8. Rounds sometimes are not completed due to weather or a match play event. However, a score for handicap purposes may still need to be posted. Rule 3.2 indicates: If at least fourteen holes are played, the remaining unplayed holes, for handicap purposes, shall be recorded as par plus any handicap strokes that the player is entitled to receive on the unplayed holes.

## HANDICAPS CONTINUED

These guidelines will be used to keep the golf played at Ocean Reef Club fair and equitable for all Members. The following guidelines:

- 100% score posting.
- The handicap committee will review results of weekly and major tournaments on a monthly basis in an effort to preserve the competitive integrity of golf at Ocean Reef Club. If deemed necessary, adjustments may be made to a player's handicap index via Rule 7.1 of the USGA Rules of Handicapping in accordance with the World Handicap System.

### HANDICAP COMMITTEE GUIDELINES

**Step 1:** The Handicap Committee will review all rounds played versus scores posted and then give Members names to Mike Leone to research and review. If these members are indeed not posting their scores, Mike will send an email to them from the Handicap Committee email address, asking the member to please post the scores that are missing in their GHIN handicap account. In this email will be the dates of the days that the Member played and didn't post.

**Step 2:** The Handicap Committee will ask them again by email to please post their scores and also let them know that if it continues to happen, the next step will be scores of 71 posted for days played where scores have not been posted.

**Step 3:** The Handicap Committee will email and inform the Member that scores of 71 have been posted for all the rounds that the Committee believes are missing posted scores.



## CAP PATROL

Our goal is to ensure that all golfers are playing with a fair handicap calculated in accordance with USGA guidelines.

We will be using “Cap Patrol”. Cap Patrol is a 3rd party software product developed to help clubs monitor player handicaps and performance. The committee can create real time reports on all of our Members. There are over 40+ data points that evaluate each Member to ensure handicaps are fair and reflective of a players’ ability.

Data includes but is not limited to:

- Trends in posted scores and index for last 12 months
- Scoring: home vs. away scores
- Scoring: tournaments vs. daily play
- Tournament success: how often players are successful in events at the club
- Posting (or not posting) of scores
- Past scoring for a particular event at the club as well as all competitive rounds

Evaluations are data driven and objective by design. Reports are often reviewed without player names to remove any personal element from decision making.

The Cap Patrol software program puts a heavy emphasis on tournament performance. If any player or team is winning more than is statistically reasonable, their handicaps will be closely reviewed by Cap Patrol

- The committee will meet once a month to review all players handicap indexes. We may meet more often notably ahead of tournaments if the committee believes it is needed.
- At that meeting we will review Cap Patrol reports on all our Members and will consider all other information including feedback from players and staff. The committee will identify any players we think need to have their index adjusted and that adjustment will be determined.
- Within 24 hours, we will communicate an adjustment to a player via a phone call, email, or letter.
- Within 48 hours after this communication, the player must notify the committee of a desire to appeal the decision. If no notice is received, the committee’s adjustment will be implemented
- After appeal, if there is an adjustment, the change will be effective immediately
- The handicap committee will adjust a player’s handicap for all Ocean Reef Club tournaments
- During this period when a player’s index has been adjusted by the committee it is still the players responsibility to continue to follow World Handicap System guidelines for posting all scores.



## DISABILITY FLAG PROGRAM

Handicap flags are given to Ocean Reef Club Members and guests who have an injury or physical condition that the normal use of a golf cart does not fully alleviate.

Handicap flags are issued by the Golf Committee to players who have a handicap vehicle decal and medical documentation. In temporary situations, this privilege will be granted for the length of time required to resolve the physical condition. In the case of a guest, handicap flags are issued for the day at the request of a member.

Handicap flags should be put in the golf bag of the player needing handicap privileges. Handicap flag recipients are required to reaffirm their need for this privilege each season.

## NORMAL CART PATTERN DAYS

When players are allowed on the fairway returning to the cart path as instructed by the white line or other such signage in front of the green, players with a handicap flag may proceed no closer than five yards (15 feet) of the green or greenside bunkers. Carts at no time should be driven on greens or tees or driven between the green and greenside bunkers. Preferably, carts should not be driven on green or tee slopes and areas of the course that could be damaged by a golf cart should be avoided.

### RESTRICTED AREAS:

From time to time, a golf hole will be roped off by the golf maintenance staff to protect the grass from cart damage. If handicap carts are allowed in these areas, carts should primarily be driven in the rough, avoiding as much traffic on the fairways as possible.

### CART PATH ONLY:

In some instances of bad weather and/or course damage or repair, it is necessary to restrict all traffic from riding the fairways. No golf carts, including those of handicap players, will be allowed on the course under these conditions.

Note: Handicap players may choose to skip holes that are cart path only. For golf score posting purposes, a player should take par plus their handicap strokes for this hole.

## BLUE MARKER SYSTEM

Both golf courses are marked with blue markers to indicate where the disability flag carts are allowed to enter and exit the areas close to the putting green.

### MEMBERSHIP

All male Members of Ocean Reef Club with an established handicap are eligible to participate in weekly events. MGA Members may invite a male guest to participate, if availability exists and the format allows.

### REGISTRATION PROCEDURE

You may sign up for weekly MGA events at any time. Registration closes at 3pm on the Sunday prior; if you would like to sign up after registration has closed, call the golf shop and we will put you in if a space is available.

### PURPOSE

To provide a weekly competitive golf opportunity for the male Members of Ocean Reef Club. In this setting, the time-honored traditions and values of this great game carry through with camaraderie and spirit that build a strong bond amongst participants.

### CREDO

- Play within the USGA Rules of Golf and handicapping, assisting others to do the same.
- Be a supporter of the Club's rules of golf operation, including those of tee times, pace of play and care of the course.
- Be a friend to the golf courses and environment.
- Be respectful of all MGA and Club players, recognizing that the traditions of golf are of a gentleman's game.

## MGA GUIDELINES AND RULES

### DATES AND TIMES

Opening Day for the MGA is November 6, 2023; closing day will be April 8, 2024. Most MGA events take place on a Monday and are played in a shotgun format starting at 9am. Complimentary clinics for MGA members will be held every Friday from 3 to 4pm. Maximum number of participants is six. Call the Golf Shop directly or contact Ben Claus to sign up.

### MULTI DAY EVENT RULE:

When signing up for a tournament scheduled over multiple days, such as the Anchor Cup or Club Championships, please understand that you are committing to participating in each day of the event (three, in the case of the Old Buddy). By withdrawing prior to the final round or match you endanger the integrity of the tournament. Any team or player that withdraws from a multi-day tournament midway through the event will be subject to MGA committee review with possible consequences including being unable to participate in the following season's tournament. All instances will be reviewed on a case by case basis. Things such as accidents, illness, injuries and historical participation will be taken into account.

## MGA GUIDELINES AND RULES CONTINUED

### PAIRINGS

Pairings will be completed on Sunday afternoon by the Golf Staff and be communicated via email for Members to view. ABCD format pairings will be randomly assigned by the tournament software in order to equalize the playing field. Some formats allow for players to pick their own teams/partners, see schedule for details.

### MGA FEES

All participants will be billed an annual fee of \$150. A \$15 weekly fee will be billed to participants when they play in a Monday game. Proceeds are given out as Pro-Shop credit to weekly winners. Players who cancel without notification will be billed the \$15 fee.

### BENEFITS

There are many benefits of being a member of the MGA. You will be eligible to play in tournaments such as the Old Buddy and ORC vs CSGC Interclub. You will receive enhanced communications from the Golf Shop including sign up dates and reminders for major tournaments, i.e. the fall Member-Guest and Triple Golf Classic, demo days, vendor promotions, sales, and more. It is also a great way to meet over 400 golfing Members of the Club.

### HOLE-IN-ONE PROGRAM

Any time an MGA member makes a hole-in-one in an MGA sanctioned event played on the Dolphin or Hammock Courses or at Card Sound Golf Club, all members of the MGA will be billed \$5 and the member who made the hole-in-one will receive the value of these charges as Golf Shop credit. The hole-in-one must be witnessed by an MGA member in order to qualify.

### BEFORE GOLF

MGA players should gather at the putting green for team and tee assignments at least 20 minutes before play.

### AFTER GOLF

The Golf Clubhouse serves as a gathering place for men to have lunch following play.

### TEES

All play is from the White Tees. Lower handicap players have the option to play from the Blue Tees. In order to be eligible to play from the Green Tees, your AGE + HANDICAP INDEX must be equal to 95 or higher. If you elect to play from the Blue or Green Tees, you must play them for the whole season.

### HANDICAPS

All "post-able" MGA event formats will have scores posted by the Golf Staff.

### OCEAN REEF CLUB VS. CARD SOUND GOLF CLUB – JANUARY 15 & 16, 2024

## MGA TOURNAMENTS

The MGA coordinates several major events each year and include:

### OLD BUDDY TOURNAMENT JANUARY 29 & 31 FEBRUARY 2, 2024

The crown jewel of the MGA schedule lets Members pick their buddy to pair up and play three days of Better Ball of Partners Match Play. Teams will play five 9-hole matches within their flight where two matches will take place on Monday, two matches on Wednesday and one match on Friday. Players will receive 90% of their course playing handicap. The lowest playing handicap in the group will play to a "0" and the other players will receive the full difference. Flights will be determined by the combined index of the team. At the conclusion of round five, our Flight Winners will compete in the four-hole shootout that will determine our Overall Champion.

### MEN'S SENIOR CLUB CHAMPIONSHIP MARCH 18 & 20, 2024

This 36-hole Stroke Play event is played on both courses to determine the champion. Any MGA member who is at least 55 years of age can compete for the championship. The Championship is broken into three age divisions: 55-64, 65-74, and 75+. At the end of 36 holes a Gross, Net and Super Senior Champion will be named. The Men's Senior Club Championship is a multi-round tournament. Per the Club's Multi-Round Tournament rule, both rounds must be played. If a player competes in Round 1 and does not play in Round 2, they will be ineligible for the tournament the following year. Burgee Cup points will not be awarded for this tournament. Pairings will be made by handicap index within their flight. Super Seniors (over 75 years old) may compete in both overall and flight divisions.

### MGA FOURBALL

If only one team is present for the tee time on the deadline date, they will be declared the winner by default. Note that if one of the players from the team is unavailable to play the match, their partner may represent their team alone against the other team.

### BURGEE CUP APRIL 1 & 2, 2024

For example, if there is a two-way tie for third place in the standings then each of those players will receive 28 points. The next player, fifth place, will receive 26 points.

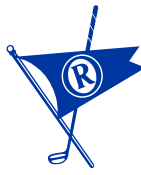

## SIGNING UP

LGA members can sign up for tee times two weeks in advance. Shotgun starts and special events can be signed up earlier on ForeTees or by calling the Golf Shop. Players who cannot complete a round in 4 hours are strongly recommended to sign up for the later starting times.

Please notify your partners and the Golf Shop if you signed up to play and are unable to participate. In case of inclement weather, please check the ForeTees website or call the Golf Shop to see if play is cancelled. Most LGA Shotgun events (usually the first meeting of the month) include an automatic charge for the Luncheon that follows. If you have signed up for an event but are unable to play, please let the Golf Shop know by calling 367-5912. If you cancel more than 48 hours prior to the event you will not be charged. All cancellations within the 48 hours prior to the event will be assessed the luncheon charge to the member account.

### **MULTI DAY EVENT RULE:**

When signing up for a tournament scheduled over multiple days, such as the Challenge Cup or Club Championships, please understand that you are committing to participating in each day of the event (three, in the case of the Member/Member). By withdrawing prior to the final round or match you endanger the integrity of the tournament and can force your opponents to play an unscheduled match against Par. Any team or player that withdraws from a multi-day tournament midway through the event will be subject to LGA committee review with possible consequences including being unable to participate in the following season's tournament. All instances will be reviewed on a case by case basis. Things such as accidents, illness, injuries and historical participation will be taken into account.

### SENIOR CLUB CHAMPIONSHIP FEBRUARY 27 & 28, 2024

To be eligible players must have paid their dues and played in 4 LGA Ladies' Days in the current season. The Senior Club Championship is a two day 36 hole stroke play event, held on both the Dolphin and Hammock Courses which will determine our Senior Club Champion (Low gross), Senior Net Club Champion and Super Senior Club Champion. 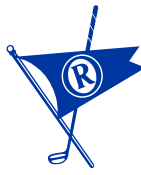
